**COVID-19 Status Report
Oak Park Village Board of Trustees**

To: Village President and Village Board of Trustees

The memo is a means to share a brief summary of information regarding Village of Oak Park operational activities in response to COVID-19. In most cases, formal public guidance or employee guidance has been publicly disseminated via the Village website or Village social media channels.

New Public Health Guidance

Today, the Village of Oak Park Department of Public Health received notification of the following new COVID-19 cases:

Excluding individuals for which street addresses are not yet determined, the State of Illinois reports a total of one thousand seven hundred and twenty-three (1723) Oak Park COVID-19 cases. It is important to note that as patient tracking and case follow-up occurs, individuals listing the number of Oak Park cases reported may change depending on residency confirmation.

The Oak Park Department of Public Health is notified of positive tests as established by state and local public health protocol. Because of privacy laws, no additional information can be released about the individuals. It is noted, that privacy precludes location information regarding individuals tested to anyone other than Public Health Officials and First Responders.

The Oak Park Department of Public Health is working closely with officials from the Illinois Department of Public Health (IDPH), investigating and notifying anyone who may have had exposure to the individual who tested positive for COVID-19. Local public health officials, hospitals and first responders are following protocols consistent with the latest guidance from the Centers for Disease Control and Prevention (CDC).

Cases related to Long-Term Care and Assisted Living Facilities

Interim Public Health Director Terry reports one new COVID-19 positive resident at Berkeley Nursing and Rehab, 6909 North Avenue. Additional, the chart below identifies eleven (11) additional positive staff members not previously reported at Berkeley. These new cases all date back to November 10th or earlier and the Public Health Department is continuing to spend considerable time working with Berkeley on required reporting.

That chart also reflects one new COVID-19 positive staff member at Oak Park Oasis, 625 N. Harlem.

New Employee in Public Health

Vanessa De La Mora recently joined the Health Department in the role of Community Health Advisor. She already has had an immediate impact assisting with contact tracing efforts. She also will assist with vaccine administration as the mental health supervisor at the point of dispensing. Beyond playing a role in the Village’s COVID-19 response, Vanessa’s position will support vulnerable populations within the community, serving as the Health Department’s liaison to organizations such as Oak Park Township, Thrive and Housing Forward that advance mental health initiatives. Prior to coming to the Village, Vanessa worked with the DuPage County Health Department as a clinician/therapist focusing on suicide prevention, substance abuse prevention, nutritional wellness and behavioral health. She has a master’s degree from the Jane Addams College of Social Work at UIC with a concentration in mental health. This position is currently funded with a COVID-19 Contact Tracing Grant Agreement the Public Health Department was awarded earlier this year by the State of Illinois.

Public Health Data

Interim Public Health Director Terry has shared the following data related to COVID-19.

“New cases per 100,000 People”. This metric looks at the number of recent COVID-19 cases per 100,000 people to describe the potential number of people who are currently ill and may be infectious. This is the number of new cases reported by IDPH in the previous week. Calculated as a rate = [Village of Oak Park case count for 7 days] / [Village population] x100,000.

- Oak Park rate: 262/100,000
- Cook County rate: 589/100,000 (11/15/2020 Through 11/21/2020)
- Target for County-level data: Cases for the week are fewer than 10 or the rate is fewer than 50 cases per 100,000 people
- Warning for County-level data: New case rate is greater than 50 cases per 100,000 people

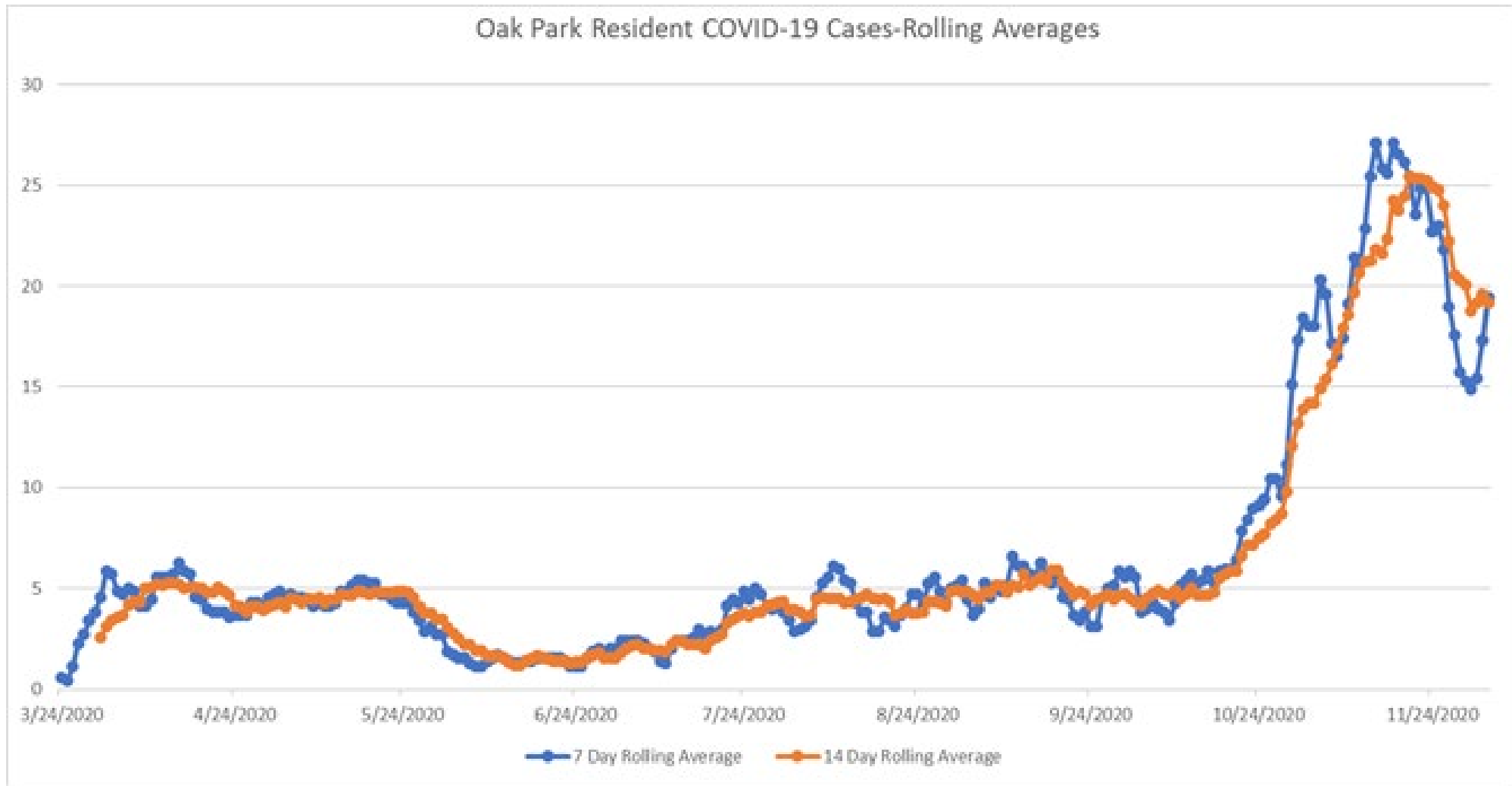

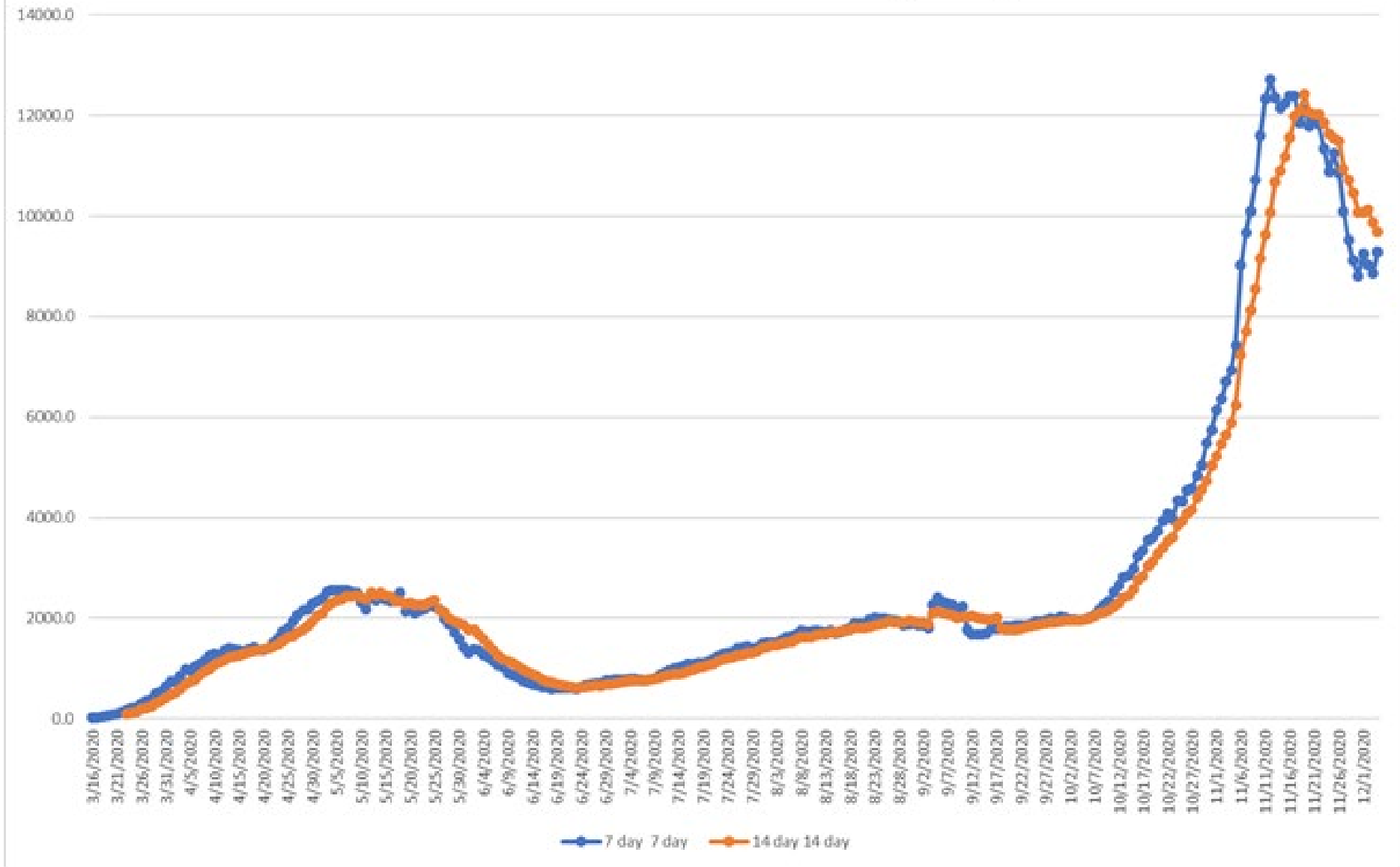
