COVID-19 Status Report Oak Park Village Board of Trustees

To: Village President and Village Board of Trustees

The memo is a means to share a brief summary of information regarding Village of Oak Park operational activities in response to COVID-19. In most cases, formal public guidance or employee guidance has been publicly disseminated via the Village website or Village social media channels.

New Public Health Guidance

The Village of Oak Park Department of Public Health received notification of the following new COVID-19 cases; since last reported:

Excluding individuals for which street addresses are not yet determined, the State of Illinois reports a total of nine hundred and six (906) total Oak Park COVID-19 cases. It is important to note that as patient tracking and case follow-up occurs, individuals listed within the number of Oak Park cases reported may change depending on residency confirmation.

The Oak Park Department of Public Health is notified of positive tests as established by state and local public health protocol. Because of privacy laws, no additional information can be released about the individuals. It is noted, that privacy precludes location information regarding individuals tested to anyone other than Public Health Officials and First Responders.

The Oak Park Department of Public Health is working closely with officials from the Illinois Department of Public Health (IDPH), investigating and notifying anyone who may have had exposure to the individual who tested positive for COVID-19. Local public health officials, hospitals and first responders are following protocols consistent with the latest guidance from the Centers for Disease Control and Prevention (CDC).

Cases related to Long-Term Care and Assisted Living Facilities

Public Health Director Charley reports a new case at Belmont Village, 1035 Madison Street, associated with a staff member.

Oak Park and Suburban Cook (Region 10) under Tier 1 Mitigation Measures

Today, Oak Park and Suburban Cook County began following Governor Pritzker and the Illinois Department of Public Health (IDPH) COVID-19 resurgence mitigations implemented because Suburban Cook County (Region 10) metrics related to sustained increases in test positivity and increased hospital admissions. These new measures were communicated to the business community via email on Monday, October 26, 2020 and have also continued to be shared on the public via the Village website and social media. The communications include the following:

Mitigation measures taking effect October 28 in Oak Park and Region 10 include:

Restaurants

- No indoor dining or bar service
- All outdoor dining closes at 11:00 p.m.
- Outside dining tables should be 6 feet apart
- No standing or congregating indoors or outdoors while waiting for a table or exiting
- Reservations required for each party
- No seating of multiple parties at one table

Meetings, Social Events, Gatherings

- Limit to lesser of 25 guests or 25 percent of overall room capacity
- No party buses
- Gaming and Casinos close at 11:00 p.m., are limited to 25 percent capacity, and follow mitigations for bars and restaurants, if applicable

Bars

- No indoor service
- All outside bar service closes at 11:00 p.m.
- All bar patrons should be seated at tables outside
- No ordering, seating, or congregating at bar (bar stools should be removed)
- Tables should be 6 feet apart
- No standing or congregating indoors or outdoors while waiting for a table or exiting

- No dancing or standing indoors
- Reservations required for each party
- No seating of multiple parties at one table

These mitigations do not currently apply to schools.

In the coming days, IDPH will continue to track the positivity rate in the region to determine if mitigations can be relaxed, if additional mitigations are required, or if current mitigations should remain in place. If the positivity rate in Region 10 averages less than or equal to 6.5% over a three-day period, there is a decrease in hospital admissions for COVID-19 like illness over a three-day period, and the three-day rolling averages of ICU bed availability and medical/surgical bed availability is greater than or equal to 20% over a seven-day period, the region will return to Phase 4 mitigations under the Restore Illinois Plan. Conversely, if the average positivity rate continues to increase over seven out of 10 days and the hospital admissions for COVID-19 like illness continues to increase over seven out of 10 days, more stringent mitigations can be applied. If the metrics remain stable, the region will continue to be monitored.

The public that Executive Orders of the Governor of Illinois and Public Health Orders related to COVID-19 issued by the Village's Public Health Director are legally enforceable. Consistent with staff actions since the start of the pandemic, we seek to educate first about compliance and will progressively enforce the Governor's Public Health orders. The Village staff has responded to complaints in this manner since March.

Public Health Data

Public Health Director Charley has shared the following data related to COVID-19.

"New cases per 100,000 People". This metric looks at the number of recent COVID-19 cases per 100,000 people to describe the potential number of people who are currently ill and may be infectious. This is the number of new cases reported by IDPH in the previous week. Calculated as a rate = [Village of Oak Park case count for 7 days] / [Village population] x100,000.

• Oak Park rate: 144/100,000

• Cook County rate: 188/100,000 10/11 through 10/17

- Target for County-level data: Cases for the week are fewer than 10 or the rate is fewer than 50 cases per 100,000 people
- Warning for County-level data: New case rate is greater than 50 cases per 100,000 people

Nearly one in every 58 residents in Oak Park is known to have contacted COVID-19 since March of this year. The Public Health Director has additionally reported 32 deaths associated with the virus.



Number and percent of cases prior to July 1 and July 1 and after.


