IV. RETURN TO OPEN MEETING AT 7:30 PM IN COUNCIL CHAMBERS

The Regular Meeting reconvened at 7:35 P.M. in Council Chambers.

V. AGENDA APPROVAL

It was moved and seconded to approve the agenda for the meeting. President Pope noted that the State of the Village Address has been postponed to the March 4 Regular Meeting. A voice vote was taken and the agenda was approved as presented.

VI. MINUTES

It was moved and seconded that the minutes of the Regular Meeting of February 4, 2013 and the Special Meeting of February 12, 2013 be approved. A voice vote was taken and the minutes were approved as presented.

VIII. NON-AGENDA PUBLIC COMMENT

There was no public comment.

IX. PRESENTATIONS, RESOLUTIONS, PROCLAMATIONS, AWARDS

There were no presentations, resolutions, proclamations or awards.

X. VILLAGE MANAGER REPORTS

A. Report on the 2009 Sign Code

Deputy Village Manager Lisa Shelley stated that this update is being provided at the request of the Village Board. Within the code is an amortization schedule that requires removal or conformity for non-conforming signs by March 23, 2014.

Village Planner Craig Failor presented an overview of steps taken from 2007 to the present. Business owners were sent a courtesy letter in March and November of 2012 indicating why their signs were deemed non-conforming, instructing them that they have until March 2014 to bring signs into compliance. Follow up courtesy letters will be sent next month, giving them a one-year notice. In March of 2014, according to the code, the Department of Building and Property Standards will be issuing official letters to the business and property owners notifying them that their sign is not in compliance. At that point, a 60-day window will be provided for removal or conformity. Three hundred and seventy two signs were identified as non-compliant. Mr. Failor gave examples of non-compliance and answered questions from the Board.

The subject of economic hardship for non-replacement was raised by Trustee Johnson. Following discussion, Trustee Salzman stated that he would like to see this issue on a future agenda to allow business owners an opportunity to address this.

B. Report on the Timetable for the Development at Lake Street and Forest Avenue

Business Services Manager Loretta Daly stated that plans for the development are currently under review. The developer appeared before the Plan Commission and approval was granted in terms of final materials presented. A planned change in one of the materials was discussed. According to the developer, this change would have no effect on the appearance of the building. Ms. Daly reported that there was no update on project financing.

Following discussion regarding the use of an in-house commercial leasing agent, Trustee Johnson asked that the Planned Unit Development and Redevelopment Agreement be reviewed, as he recalled using a national leasing agent was what the Board agreed to. Ms. Daly gave an update regarding the Village's financing of the garage portion of the project. Four financial institutions are being considered.

The Illinois Historic Preservation Agency has contacted the Village regarding a review of this project. Ms. Daly did not anticipate any concerns, as the Village's Historic Preservation Commission has already done a review. Also, staff was in the process of

working with the developer on an RFP for the operation of the garage.

- Trustee Salzman asked for clarification regarding early voting and for an update on the progress of the new Village website.
- President Pope also reminded residents about the Comprehensive Plan Meeting and added that the keypad polling component gives those voting the opportunity to view the results in real-time. He reiterated Trustee Lueck's comments in regards to residents being able to help highlight and guide some of the activities and directions that will move forward as part of the planning process.
