COVID-19 Status Report

The memo is a weekly status report presented Wednesdays and provides a brief summary of information regarding Village of Oak Park operational activities in response to COVID-19.

### **New COVID-19 Cases**

The Village of Oak Park Department of Public Health received official notification of 41 COVID-19 cases from March 3-9, 2022. This is a 60.2% decrease over the last 7-day period, and a 73.3% decrease over the cases 30 days ago.

### **COVID-19 Community Transmission Rates**

Based on the positives cases reported to the Village of Oak Park, for the week of March 3-9, our weekly COVID-19 rate of 75 cases per 100,000 placed us in substantial community transmission range for the first time since Nov 2, 2021. The CDC recommends tracking community transmission rates and using this to set control measures for hospitals and congregate living facilities.

These numbers do not reflect those who tested positive using at home self-administered test. At-home test must be confirmed at an official testing site (pharmacy, physician office, health department, school, etc.) so that information can be transferred to the health department.

### **COVID-19 Community Levels**

On February 25, 2022, the CDC introduced COVID-19 Community Levels of low, medium, and high. Oak Park is in the low level, as defined by less than 200 cases per 100,000 (we have 75 per 100,000), and less than 10% of staffed inpatient beds occupied by COVID-19 patients (we have 4.2% of our hospital beds occupied by COVID-19 patients). We currently track our COVID admissions as cumulative totals, and the CDC definition requires new cases per 7 days. We will continue to adapt our data to align with CDC definitions so we can track and report on this metric.

### **Deaths**

There were 0 reported deaths to residents from COVID-19 in the community for this time period.

## Oak Park Residents Vaccinated

Oak Park reports 87.7% of residents receiving their first dose and 79.9% completing their primary vaccination series.

The Oak Park Department of Public Health is hosting vaccination clinics for anyone age 5 and older who need their first, second, or booster dose. Immunocompromised adults are encouraged to get their fourth dose, and immunocompromised children over the age of 5 are encouraged to get their third dose when eligible.
