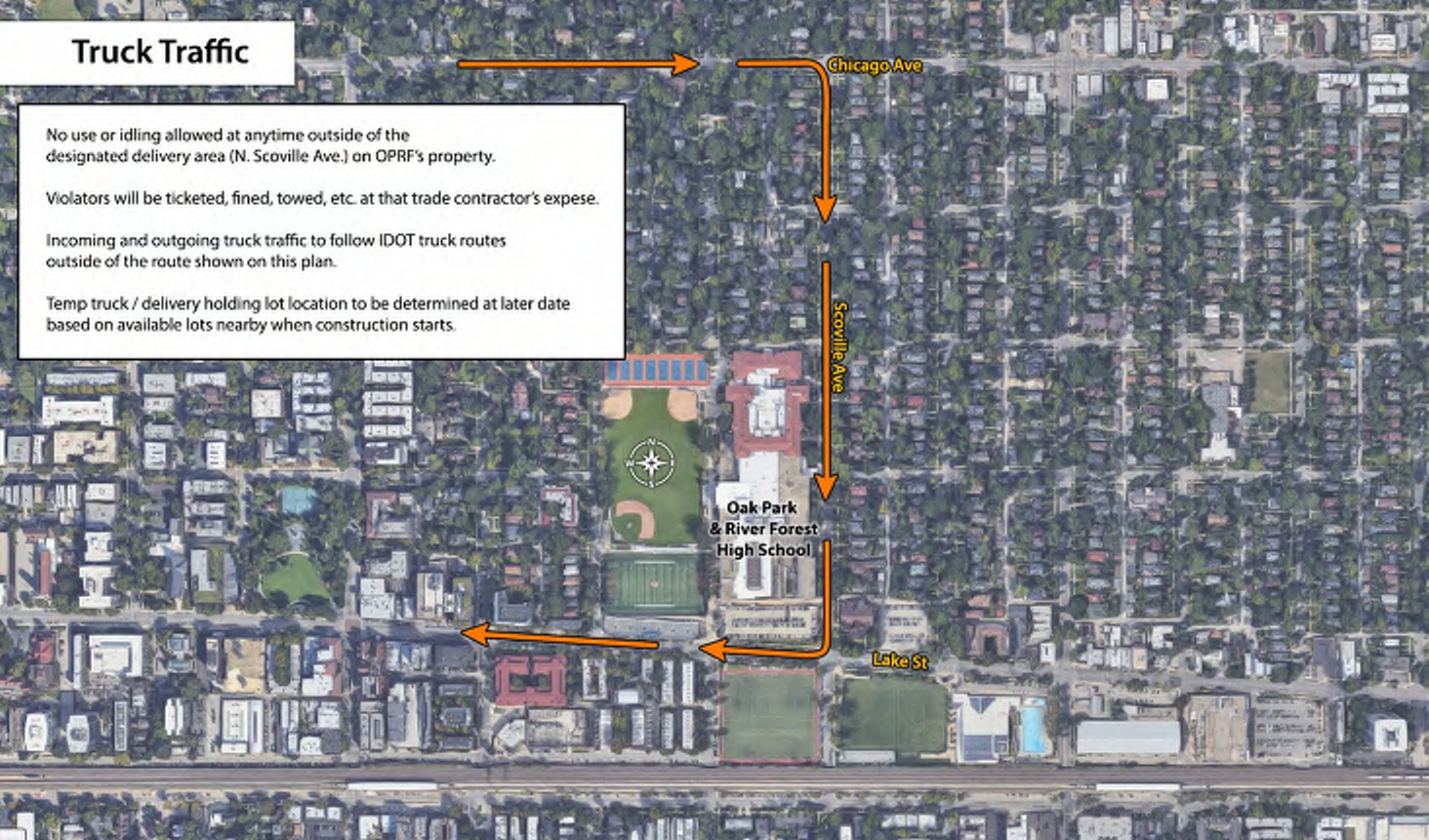
## Truck Traffic
