Grove Street Apartments

David Sokol explained that as a part of the Planned Development process developers are required to include public art within their project. As such developers appear before the PAAc to review their public art proposals seeking approval of the art plan as part of the final PUD agreement. Additionally, before a project can attain their final Certificate of Occupancy all requirements of the PUD agreement must be met including the approved public art plan which is what the representatives from the Grove Street Apartments was seeking this evening.

Perry Viette and Dennis Langley presented for approval the final design of the decorative fencing that is to be installed a per the public art stipulation in the Planned Development Agreement. P. Viette explained that the design was inspired by the history of auto sales out of this site, and that a professional artist had been hired out of New York to craft the pieces. P. Vietti also indicated that while the Planned Development Agreement stipulates a decorative fence along Madison St, they will also be installing this along the fencing at the South of the building.

In general the PAAC was very enthusiastic about the design of the fencing and that it was to be installed in two locations. A motion was made to approve the fencing design as presented.
