Kathryn Lee Noll: Community Development Citizens Advisory Committee

As the Oak Park Farmers' Market Vendor Representative, he feels he would be able to bring forward the concerns of the participating vendors to the commission and the village. His work with other area markets during the week could offer insights into other best practices that may benefit Oak Park, as well interacting with other vendors that may be good fit to the Oak Park Market.
