SPECIAL NOTE: The Community Design Commission will conduct a remote meeting with live audio available and optional video. The Village President has determined that an in-person meeting is not practical or prudent due to the COVID-19 outbreak during Governor JB Pritzker's current disaster proclamation. It is also not feasible to have a person present at the meeting due to public safety concerns related to the COVID-19 outbreak.

E. New Business / Public Hearing and Resolution - Sitting as the Design Review Commission

- The Applicant is seeking variations from Sections 7-7-14 (B) and Section 7-7-15 (D) (1) (b) of the Village of Oak Park Sign Code. Section 7-7-14 (B) requires that a menu board sign shall not exceed six (6') feet in height. The applicant is seeking a sign variance to install a 6'-10" tall menu board. Section 7-7-15 (D)(1)(b) allows one wall sign per street frontage. In order to install both a 23.33 square foot "Dunkin" sign and a 14.4 square foot "Baskin Robins" sign on the north elevation of the building, the applicant is requesting a sign variance.
